## Add one — The Song Continues for “Children’s Day”

“Mr. Nicky is awesome in his support for *Children’s Day* and the children of the world in song and in deed. He surely needs our backing.”

**Children’s Day** observations in the United States predate both Mother’s and Father’s Day. The day to celebrate children dates from the 1860s and earlier. The Methodist Episcopal Church at the Methodist Conference of 1868 recommended that the second Sunday in June be observed annually as **Children’s Day**. The General Assembly of the Presbyterian Church in 1883 designated the “the second Sabbath in June as *Children’s Day*.”

The governors of Illinois and Wisconsin have issued proclamations proclaiming the second Sunday in June as **Children’s Day**. The cities of Aurora, Ill.; Fort Collins, Colo.; and Vancouver, Wash., also have issued proclamations.

*Chase’s Calendar of Events* cites Children’s Sunday and notes that The Commonwealth of Massachusetts issues an annual proclamation for *the second Sunday in June*.

Numerous churches and denominations currently observe *the second Sunday in June* including the African Methodist Episcopal Church, African Methodist Episcopal Zion Church, and the Christian Methodist Episcopal Church.

The **Children’s Day** website also offers helps and challenges parents, individuals, churches/houses of worship, schools/places of education, government/community and businesses to sign commitment cards directed at affirming America’s children. They pledge to “commit myself (ourselves), in the coming year, to love, cherish, nurture (physical, mental, emotional, & spiritual needs), and affirm...” They can also make a commitment beyond America to the world’s children.
